Notice of Intent to Adopt Regulations

DSS Regulation 21-02 (PR2021-045) – Requirements for Payment of Chiropractic Services – Removing Coverage Exclusion for Initial Visit

In accordance with section 4-168(a) of the Connecticut General Statutes, the Department of Social Services (DSS) gives notice that pursuant to the authority of sections 17b-3 and 17b-262 of the Connecticut General Statutes, the Department intends to amend the Regulations of Connecticut State Agencies to update the regulation concerning payment for chiropractic services to remove the exclusion of coverage for the initial visit. A description of the proposed regulation, a statement of the purposes for which it is proposed, and information concerning when, where, and how interested parties may present views on and obtain copies of the proposed regulation is provided below.

1. Description of the Proposed Regulation

The proposed regulation updates the chiropractic services regulation (section 17b-262-540 of the Regulations of Connecticut State Agencies) to remove the exclusion of coverage for the initial visit.

2. <u>Statement of Purpose</u>

The purpose of this regulation is to update the department's regulations regarding payment to chiropractors.

(A) The problems, issues or circumstances that the regulation proposes to address: Pursuant to Section 331 of Public Act 21-2 of the June 2021 special session, DSS reinstated Medicaid coverage for chiropractic services effective October 1, 2021. The current DSS chiropractic services regulation, however, prohibits coverage for an initial chiropractor visit for exam and diagnosis. Based on stakeholder feedback in connection with the restoration of coverage and after additional review, DSS has determined that this coverage exclusion should be removed in order to facilitate the provision of the initial exam necessary for chiropractors to ensure proper diagnosis and treatment planning.

(B) The main provisions of the regulation: This regulation removes the prohibition on coverage for an initial chiropractic visit for exam and diagnosis.

(C) The legal effects of the regulation, including all of the ways that the regulation would change existing regulations or other laws: This regulation removes the coverage exclusion detailed above.

3. Statutory Authority for the Proposed Regulation

The statutory authority for the proposed regulation is sections 17b-3 and 17b-262 of the Connecticut General Statutes.

4. Public Comment Period

Public comments must be submitted during the time period from October 20, 2022 through November 21, 2022.

DSS will hold a public hearing on the proposed regulation if requested by fifteen persons, by a governmental subdivision or agency or by an association having not less than fifteen members, if notice of the request is received by the agency not later than fourteen days after the date of posting of this public notice by DSS on the eRegulations System.
