Explanation of State Impact:

A revenue gain to the general fund is expected to result from the adoption of this proposal.

The proposal includes two parts. The first part is the incorporation by reference of licensing and safety provisions of the Nuclear Regulatory Commission (NRC). This portion of the proposal improves consistency with existing federal regulations as well as consensus industry standards currently being implemented by the regulated community. The second part is the creation of civil penalties for radiation materials safety, security and transportation violations.

There is an anticipated increase in revenue due to these changes. The increased revenue will support the additional positions needed to develop and implement the program. DEEP will administer the NRC licensing provisions with lower expenses resulting in increased revenue into the General Fund. DEEP has dedicated two current staff members and will hire and train three additional staff to administer the licensing program. The NRC provides training and funds training travel for agreement state personnel. The licensing fees collected by DEEP will exceed the cost to administer the program, resulting in a revenue gain to the state. Per NRC, DEEP anticipates that approximately 110 licenses will be transferred to DEEP. This includes the 102 CT license holders plus some additional one that are currently federal licenses with use locations in the state that will need to become CT specific licenses. OPM has determined that the appropriate revenue fees for CT licenses will be set equivalent to the federal fee schedule and will not result in an increase in fees to licensees in the state. The revenue from fees from licensees is anticipated to be about \$1.73 million dollars per year. The revenue gain has been benchmarked against fees collected in Vermont, Massachusetts, New York, and Rhode Island. Connecticut would also collect a nominal amount of money for reciprocity fees (NRC charges \$2,500 per year per license) for sources who are licensed in other states but may be doing business in Connecticut and for any civil penalties issued pursuant to section 22a-6 of the general statutes of Connecticut. DEEP will experience a minimal revenue gain from the collection of civil penalties to the extent violations occur. Based on recent NRC violations, we would expect one to three enforcement actions involving civil penalties in a given year. Violators will experience no change in penalties as the civil penalties assessed by DEEP are generally equivalent to those imposed by the NRC currently.

For state facilities that are now NRC licensees, licensing costs will be reduced Connecticut State Agencies (UCONN Health, Connecticut Agriculture Station, DOT, DPH and DEEP) pay \$100,600 annually to NRC in radioactive material license fees which would be exempted under a new Materials Program. NRC also provides training and travel expenses for state personnel. Per section 22a -153(e) of the general statutes of Connecticut all license fees are deposited in the General Fund.

Explanation of Municipal Impact:

No municipality is expected to experience costs or savings as a result of the adoption of this proposal. There are currently no municipalities licensed by the NRC.⁶
