## DEPARTMENT OF PUBLIC HEALTH NOTICE OF INTENT TO ADOPT REGULATIONS

In accordance with the provisions of section 4-168(a) of the Connecticut General Statutes, the Department of Public Health ("DPH") hereby gives notice of its intent to adopt regulations concerning Abortions as authorized by sections 19a-602, 19a-116 and 19a-2a of the Connecticut General Statutes. A description of the proposed regulations, a statement of the purposes for which they are proposed, and information concerning when, where and how interested parties may present views on and obtain copies of the proposed regulations is provided below.

The Department has implemented policies and procedures as authorized pursuant to section 19a-483c(b) of the Connecticut General Statues. Policies and procedures implemented pursuant to this section shall be valid until such time as final regulations under this section are adopted.

# Comment Period (Conn. Gen. Stat. § 4-168 (a)(1)(A))

A comment period of not less than thirty days shall begin on August 19, 2024 via the eRegulations System website, and shall end on September 20, 2024.

# Description of Proposed Regulations (Conn. Gen. Stat. § 4-168 (a)(1)(B))

Section 1 of the proposed regulation amends Section 19-13-D54 of the Regulations of Connecticut State Agencies to clarify definitions including the definition of medication abortion, comply with the requirements of Section 19a-602 of the Connecticut General Statutes to include all licensed providers who may provide abortion services, and revise the subsections on reporting and standards of care to reflect current best practices. Section 1 also incorporates those provisions regarding informed consent, counseling, and emergency preparedness previously located in Section 19a-116-1 of the Regulations of Connecticut State Agencies that are statutorily required pursuant to Section 19a-116 of the Connecticut General Statutes. Section 2 of the proposed regulation repeals Section 19a-116-1 of the Regulations of Connecticut State Agencies to avoid duplication.

# Statement of Purpose (Conn. Gen. Stat. § 4-168(a)(1)(C))

The Commissioner of the Department of Public Health is proposing these revisions to sections 19-13-D54 and 19a-116-1 of the Regulations of Connecticut State Agencies in order to comply with Connecticut General Statutes § 19a-602. Public Act 22-19 amended section 19a-602 of the Connecticut General Statutes to specify that certified nurse-midwives,

advanced practice registered nurses, and physician assistants licensed in the state of Connecticut may provide abortion services within their respective scope of practice. In addition, the Department is proposing these revisions to avoid duplication and to reflect current best practices.

## Statutory Authority (Conn. Gen. Stat. § 4-168(a)(1)(D))

The statutory authority for proposed regulations is §§ 19a-602, 19a-116 and 19a-2a of the Connecticut General Statutes.

In addition to submitting written comments to the Department as described above, interested persons may verbally present their views on the proposed regulation at a public hearing. A public hearing will be scheduled as detailed below if requested by fifteen (15) or more persons, a governmental subdivision or agency, or an association having not less than fifteen (15) members provided that notice of such request is received by the agency not later than fourteen (14) days after the date of posting of this notice by the agency on the eRegulations system.
