Notice of Intent

In accordance with the provisions of Section 4-168(a) of the *Connecticut General Statutes* (CGS) the **Office of Early Childhood** hereby gives notice that it proposes to adopt a regulation concerning **Youth Camps**.

Comment period (See CGS section 4-168(a)(1)(A))

A comment period of not less than thirty days shall begin upon posting of this notice to the eRegulations System website and shall end on **February 4, 2022**.

Detailed description of the proposed regulation. (See CGS Sec. 4-168(a)(1)(B))

The purpose of this regulation is to amend the regulations governing youth camps to require the director of small craft waterfront areas to be at least twenty years of age, expand the number of small craft safety programs recognized, establish requirements to satisfy the mandates of the reauthorization of the Child Care and Development Block Grant (CCDBG), recognize cardiopulmonary resuscitation training currently recognized for child care programs, add language consistent with the requirements of PA 21-82 pertaining to background checks, and make technical revisions
