Banning, or even phasing out gas-powered cars is short-sighted.

While electric vehicles do serve a purpose for many people, they are not suitable for everyone or every need.

EVs are expensive. Even with state & federal rebates & incentives, only the wealthy can afford EVs.

EVs are built with materials that are not available domestically in sufficient quantities to replace even a fraction of gas-powered cars with EVs. Widespread, or worse, mandated production of EVs makes us even more reliant on China and the Chinese Communist Party.

There is not enough lithium being mined domestically to satisfy the desired pace of conversion to EVs.

Mining rare earth minerals in the quantities necessary would cause vast environmental damage.

Of course, lithium and rare earth minerals can be obtained from China, where they do not care how much environmental damage their mining operations cause.

Batteries beyond their useful life (estimated at about 5 years) become hazardous waste.

EVs take too long to charge. The majority of people do not want an EV, and are not willing to sit and wait for an hour to recharge, when they can refuel their Internal Combustion vehicle in two or three minutes.

Connecticut has among the highest electricity prices in the nation. Our policy makers in Hartford have also made it more difficult to build new power plants. To add insult to injury, they closed the trash-to-energy plant without having a replacement plan in place. So we have lost power generation capacity, in addition to increasing trash disposal costs.

Increasing demand for electricity, while stifling the supply of electricity would cripple our economy, and would hit low-income people the worst.

While EVs can be one component of our transportation strategy, it is never wise to place all of your eggs into one basket. There will always be a need for internal combustion vehicles, whether they run on gasoline, propane, compressed natural gas, or hydrogen.

Please do not mimic California. Have you looked at California lately? The state is a mess, and is losing population in droves, due to its failed policies.

NO to banning or phasing out gas-powered vehicles.

Connecticut, once the Constitution State, proposes regulations that will eliminate individual's rights, diminish household incomes, and place individuals in harm's way. And adding insult to injury, as taxpayers, we're paying for these injustices.

(I am not going to go into all the issues with EVs because others will do so.)

I sit here fuming: Where does it end? When do I get a choice? During Covid, I got a taste of "executive orders" - orders that did not consider individuals with disabilities. What else will you dictate because YOU know what's best for my life? What other restrictions and burdens will YOU place on me to make living for me more difficult? Think! Why would I want to get out of my car to charge it, exposing myself as an "easy mark"? Maybe it would never happen, but YOU would be making me live with the possibility, and experience the anxiety. Crime is up; that's another story.

That a regulation is being proposed for EVs following California standards is ridiculous beyond consideration - just consider the difference in climate conditions and the effect of cold temperatures on EVs.

Governor Lamont, once again, can follow what other governors have done. And if it fails, culpability is removed.

Because of the batteries they require, they are twice as heavy as gas powered vehicles, and therefore will cause twice as much damage when they are involved in accidents. The probability that EV's will cause fatal accidents is also twice as likely. Existing parking garages were built to handle X amount of weight. If we double the amount of weight an average car weighs, existing parking garages will not be able to handle the excess weight and the possibility of collapse magnifies. In fact, at least one parking garage has already collapsed because of this reality.
2. Electric Vehicles (EV's) are dangerous. When their batteries come in contact with water, fires have occurred. When EV's are involved in accidents, they explode with violent fireballs, not just once, but continuously for long periods of time. It is almost impossible to put out the resulting fires. Several you tube videos exist showing these explosions and I suggest you check them out.
3. Electric Vehicles (EV's) cost significantly more than gas powered vehicles. A conservative estimate is \$13,000 more than a comparable gas-powered vehicle. We are getting crushed by inflation and now you want to mandate very expensive EV's. This is unconscionable.
4. When Electric Vehicles (EV's) need their batteries replaced, the cost will be \$15,000 to \$20,000 dollars. What I am hearing is that EV owners are having to replace their batteries after only two years. How do you expect the average citizen to pay for these?
5. We do not have the domestic resources to build Electric Vehicles. Lithium comes mostly from China or countries not friendly to the United States. By mandating that only EV's be sold in Connecticut beginning in 2035, you are making the USA dependent on our enemies, and are enriching our enemies. Not a great strategy.

6. To mine enough lithium to make one EV car battery, 500,000 lbs. of earth must be displaced. Also, the amount of carbon emissions necessary to displace 500,000 lbs. of earth will exceed the CO2 emissions savings resulting from the operation of an EV. China, India, and most rare mineral rich countries don't give a hoot about the environment. They are building coal plants like crazy and will strip mine no problem. We would be in effect financing their polluting the environment. We would be empowering countries that want to destroy us. It makes zero sense.
7. What do you do with the EV batteries when they have to be disposed of. The batteries themselves are way more dangerous for the environment than batteries used in gas powered vehicles.
8. We don't have the infrastructure to support mandating that only EV's are sold in Connecticut starting in 2035. Even if we have enough charging stations, we don't have the power grid to support the electric demand that this mandate would create. The only way to increase the capacity to the electric grid would be to build a lot more power plants, including coal fired power plants, which would defeat the whole purpose of mandating only electric vehicles.
9. The electric waves bouncing around in all Electric Vehicles is potentially catastrophic for human health. Before mandating a change to all EV's starting in 2035, you need to full explore all the possible harmful health side effects.
10. Many of our politicians, maybe some of our Ct. Politicians, are taking bribes from China. They are selling our country out to enrich themselves. There is no other reason to explain their support for this destructive legislation. We cannot let this legislation pass.

Passing this legislation to save the environment is a ridiculous argument. We have the cleanest air and cleanest water of any industrialized country in the world. By passing this legislation you will be polluting the environment far more because of the above reasons. You will be making us subservient to China. You will be hurting everyone financially unnecessarily. You will be endangering everyone's health unnecessarily. You will be making the biggest mistake you could possibly make.
