### **Technical Corrections:**

1. A page number should be inserted on the proposed regulation page, for proper form.
2. On page 1, "Section 1. Section 5-273-60 of the Regulations of Connecticut State Agencies is amended to read as follows:" should be added before the catchline, for proper form.
3. On page 1, in the catchline, "**notice of withdrawal**" should be "**notice of withdrawal**" for proper form.
4. Throughout subsections (a) and (b) of section 5-273-60, "board" should be "[board] Board", for accuracy.
5. On page 1, in section 5-273-60(c) should be rewritten as follows for clarity and accuracy:

"(c) A party seeking to withdraw a complaint or Petition filed under the Act shall notify the Board not later than forty-eight (48) hours prior to the scheduled start time of a hearing on such complaint or Petition. If no such notice is given by the party seeking to withdraw such complaint or Petition, the party shall appear at the scheduled hearing and withdraw the complaint or Petition on the record."

**Sec. 5-273. Powers of State Board of Labor Relations. The State Board of Labor Relations shall administer sections 5-270 to 5-280, inclusive, as follows:**

(a) The board shall exercise those powers and perform those duties which are specifically provided for in said sections. Those powers and duties shall be in addition to and exercised completely independent of any powers and duties specifically granted to it by statutory enactment.

(b) The board shall have authority, from time to time, to make, amend and rescind such rules and regulations as may be necessary to carry out the provisions of sections 5-270 to 5-280, inclusive. Such rules and regulations shall be effective upon passage, in conformance with the terms of chapter 54.
