Notice of Intent

In accordance with the provisions of Section 4-168(a) of the *Connecticut General Statutes* (CGS) the **Freedom of Information Commission** hereby gives notice that it proposes to adopt a regulation concerning **Organization and Rules of Practice**.

Comment period (See CGS section 4-168(a)(1)(A))

A comment period of not less than thirty days shall begin upon posting of this notice to the eRegulations System website and shall end on **July 3**, **2025**.

Detailed description of the proposed regulation. (See CGS Sec. 4-168(a)(1)(B))

These proposed amendments to the Commission's current regulations would make the following substantive changes:

- provide the Commission greater flexibility to determine the filing date for briefs and memoranda of law submitted by parties who argue before the Commission at one of its regular meetings (currently §1-21j-26(d));
- require business organizations to name their authorized representative when filing a complaint with the Commission (currently §1-21j-28(a));
- provide greater flexibility for parties to request, and greater discretion for hearing officers to grant, requests for the continuance or postponement of contested case hearings (currently §1-21j-34a(b));
- allow the Commission to apply to the Judicial District of Hartford, rather than New Britain, for an order to enforce a subpoena, in conformance with a statutory change allowing all state agencies to do the same (currently §1-21i-36(c)); and
- clarify the process that the Commission must follow when lodging in camera records with the Superior Court on an administrative appeal (currently §1-21j-37(f)).

In addition, these proposed amendments contain various minor, grammatical, technical, and conforming changes, which include updates to the Commission's office mailing address; expanded contact information requirements for parties listed on the Commission's complaint form; and updates to references to the Regulations of Connecticut State Agencies, the Uniform Administrative Procedure Act, and the Personal Data Act.

Last, these proposed amendments update the section and subsection numbers of each of the Commission's regulations to conform with their current statutory section numbers (see "Correlated Table").

Statement of the purposes for which the regulation is proposed. (See CGS Sec. 4-168(a)(1)(C))

The objective of the proposed regulation is to revise the Commission's regulations governing its organization, including updating its current address, updating and refining its rules of practice and updating and eliminating outdated statutory references. The regulations have not been updated since 1999.
