REGULATION PROPOSAL

Certification of Forest Practitioners

Section 1. Subsection (g) of Section 23-65h-1 of the Regulations of Connecticut State Agencies is amended to read as follows:

Examinations for Initial Certification

(g) Except as provided in [subdivision] <u>subdivisions</u> (3) <u>and (6)</u> of subsection (c) of section 23-65h of the general statutes and in subsection (i) of this section, all applicants for initial forest practitioner certification [must] <u>shall</u> achieve a passing grade on a written examination in order to be granted certification.

Sec. 2. Subsection (l) of Section 23-65h-1 of the Regulations of Connecticut State Agencies is amended to read as follows:

Certificate Renewal

- (*l*) (1) An application for renewal of a certificate shall be submitted to the commissioner no less than 60 calendar days prior to the expiration date of the certificate. The application for renewal of certification shall be on a form provided by the commissioner, shall be accompanied by payment of the application fee in accordance with subsections (r) and (s) of this section, shall include evidence of satisfaction of all continuing education requirements of this section, and shall include information concerning whether the applicant has engaged in any of the activities set forth in subdivisions (1) to (3), inclusive, of subsection (a) of section 23-650 of the general statutes, or has been convicted of a felony associated with the conduct of a regulated forest practice.
 - (2) The commissioner may grant a sixty-day extension for any forest practitioner who failed to submit a complete application for renewal prior to the expiration date of such forest practitioner's certification. Any forest practitioner granted such an extension shall submit a complete application for renewal not later than the end date of such sixty-day extension period. Any such renewed certification issued by the commissioner following such a sixty-day extension period shall not require reexamination by such forest practitioner prior to such issuance but shall require the submission of an additional fee of \$100.00.

Sec. 3. Subsection (o) of Section 23-65h-1 of the Regulations of Connecticut State Agencies is amended to read as follows:

Continuing Education Standards for Renewal of Certification

(o) In accordance with section 23-65i of the general statutes, all certified forest practitioners shall participate, [biennially] <u>during the period of such certification</u>, in a relevant program of

professional education to improve or maintain professional forestry skills that is sponsored by the Department of Energy and Environmental Protection, the New England Society of American Foresters, [the] <u>The</u> University of Connecticut, Yale University[,] <u>or</u> the Connecticut Cooperative Extension System, or [any university having a forest management or forest products harvesting curriculum accredited by the Society of American Foresters] <u>in another program approved by the department.</u>

Sec. 4. Subdivisions (3) to (5), inclusive, of subsection (q) of Section 23-65h-1 of the Regulations of Connecticut State Agencies are amended to read as follows:

Renewal of Certification

- (3) Each applicant for renewal of Forester certification shall participate, <u>during the period of such certification</u>, in a [biennial] program of professional education equivalent to [six (6)] <u>twelve</u> (12) CEU's.
- (4) Each applicant for renewal of Supervising Forest Products Harvester certification shall participate, during the period of such certification, in a [biennial] program of professional education equivalent to [four (4)] eight (8) CEU's.
- (5) Each applicant for renewal of Forest Products Harvester certification shall participate, <u>during</u> the period of such certification, in a [biennial] program of professional <u>education</u> equivalent to [three (3)] <u>six (6)</u> CEU's.

Sec. 5. Subsections (r) and (s) of Section 23-65h-1 of the Regulations of Connecticut State Agencies are amended to read as follows:

FEES

- (r) The fee for applying for certification or renewal of certification shall be \$235.00. The fee shall be submitted simultaneously with the application for certification or renewal of certification and certification shall not be granted or renewed prior to payment of the fee. The fee provided in this section shall be non-refundable. [The application fee required by this section shall be paid by check or money order payable to Department of Energy and Environmental Protection. The check or money order shall state on its face, "Forest Practitioner Certification Application Fee".]
- (s) An applicant for forest practitioner certification or renewal of certification shall, if required by this section to take an examination, pay an examination fee of \$65.00 for each examination. The fee provided in this section shall be non-refundable. [The fee required by this section shall be paid by check or money order payable to the Department of Energy and Environmental Protection. The check or money order shall state on its face, "Forest Practitioner Certification Examination Fee".]

- 4. In compliance with Conn. Gen. Stat. § 4-168(a)(4), the Department of Energy and Environmental Protection on March 23, 2023, gave notice electronically or provided paper copies to all persons who made requests for advance notice of its regulation-making proceedings.
- 5. The Department of Energy and Environmental Protection received no requests for a paper copy or electronic version of the proposed regulation, as described in Conn. Gen. Stat. § 4-168(a)(5).
- 6. In compliance with Conn. Gen. Stat. § 4-168(a)(6), the Department of Energy and Environmental Protection prepared a fiscal note, including an estimate of the cost or of the revenue impact of the proposed regulations (A) on the state or any municipality of the state, and (B) on small businesses in the state, including an estimate of the number of small businesses subject to the proposed regulation and the projected costs, including but not limited to, reporting, recordkeeping and administrative, associated with compliance with the proposed regulation and, if applicable, the regulatory flexibility analysis prepared under Conn. Gen. Stat. § 4-168a.
- 7. All interested persons were given reasonable opportunities to submit data, views or arguments, orally at a hearing if granted under Conn. Gen. Stat. § 4-168(b) or in writing, concerning the proposed regulations and to inspect and copy or view online and print the fiscal note referred to in paragraph (6) above.

- 8. No request for an opportunity to present oral argument was made by fifteen persons, by a governmental subdivision or agency or by an association having not less than fifteen members, within fourteen days of the posting of the notice on the eRegulations System.
- 9. The Department of Energy and Environmental Protection considered fully all written and oral submissions respecting the proposed regulation.
- 10. No revisions to the fiscal note referred to in paragraph (6) above were necessary in light of the submissions respecting the proposed regulation.
- 11. In compliance with Conn. Gen. Stat. § 4-168(e), on July 10, 2023, the Department of Energy and Environmental Protection posted on the eRegulations System notice that it decided to take action on the proposed regulation and has provided such notice electronically to all persons who submitted oral or written comments concerning the regulation and has provided a paper copy of such notice to all persons who submitted comments in a non-electronic format.
